This application enables you to request a certificate of belonging to the navigation of the Rhine or an amendment of your current certificate of belonging.

Only the Contracting State in which the vessel is registered may issue and withdraw the certificate of belonging. If the vessel is not registered in one of the Contracting States, the competent State shall be the one in which the owner's domicile or residence or the headquarters of the owner's company is located.



The certificate of belonging can only be issued if the vessel's owner:

- a. as a **natural person** is a national of one of the Contracting States and his domicile or habitual residence is in one of these States, or
- b. as a **legal person governed by public law** is established in accordance with a Contracting State's law and has his headquarters there, or
- c. as a **legal person or company governed by private law** is established in a Contracting State in accordance with its laws, and:
 - has its headquarters and centre of commercial activity as well as the place from which the vessel is operated in this Contracting State
 - is managed and directed by individuals, most of whom are nationals of the Contracting States and have their domicile or habitual residence as well as, in the case of a legal person, their headquarters in one of these States.

> Documents to be provided to obtain the certificate of belonging to the navigation of the Rhine

- » Copy of a passport or valid proof of identity of the owner, of the member/members of the owner's board of directors (if applicable)
- » Copy of an excerpt from the owner's Chamber of Commerce entry (less than 6 months old). If the owner is a legal person and the latter is part of a holding company it will also be necessary to provide an excerpt relating to the holding company. The excerpt must identify a natural person as director (if applicable)
- » Valid copy of the inspection certificate
- » Copy of a vessel registration certificate
- » Valid operator's certificate
