Priority Areas

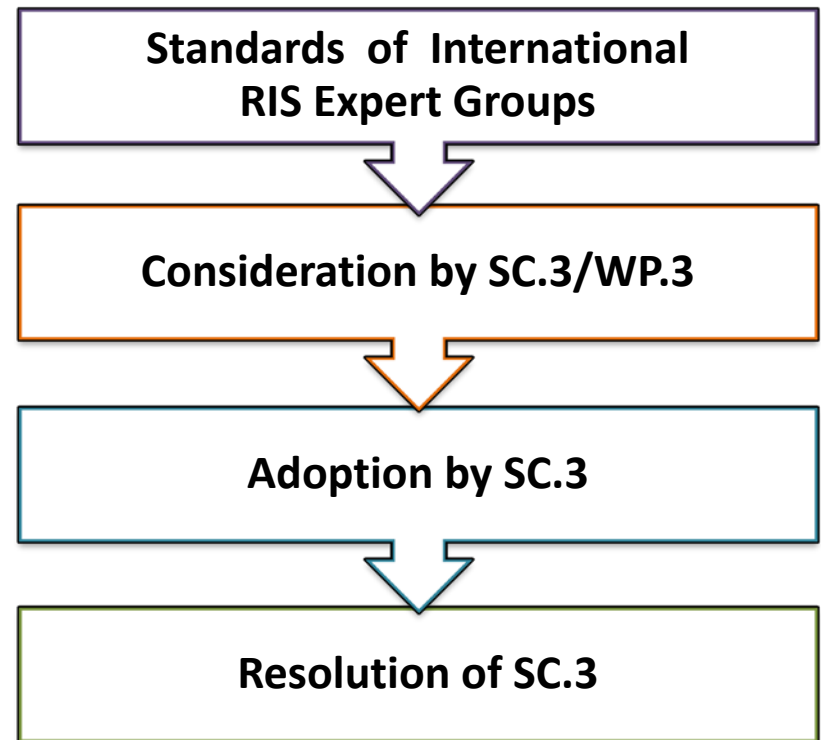
- **Policy Recommendation No 3**

Integrated pan-European infrastructure and services for Inland Waterway Transport
- **Overarching goals and objectives 2016-2021**
Fostering RIS and other ICT in all UNECE Member States



Technical Standards

Harmonization & Unification Process

- Started in 2001 with Resolution No. 48
- Pan-European standards based on those developed by International RIS Expert Groups
- In consultation with River Commissions

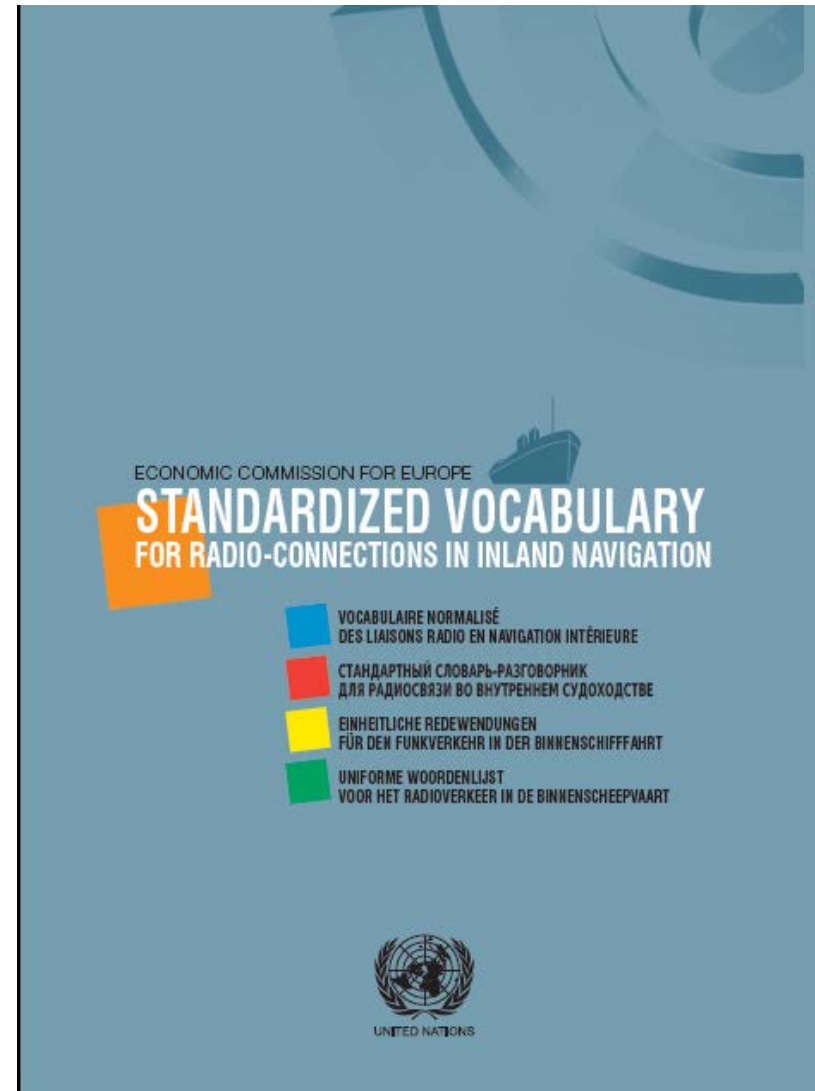

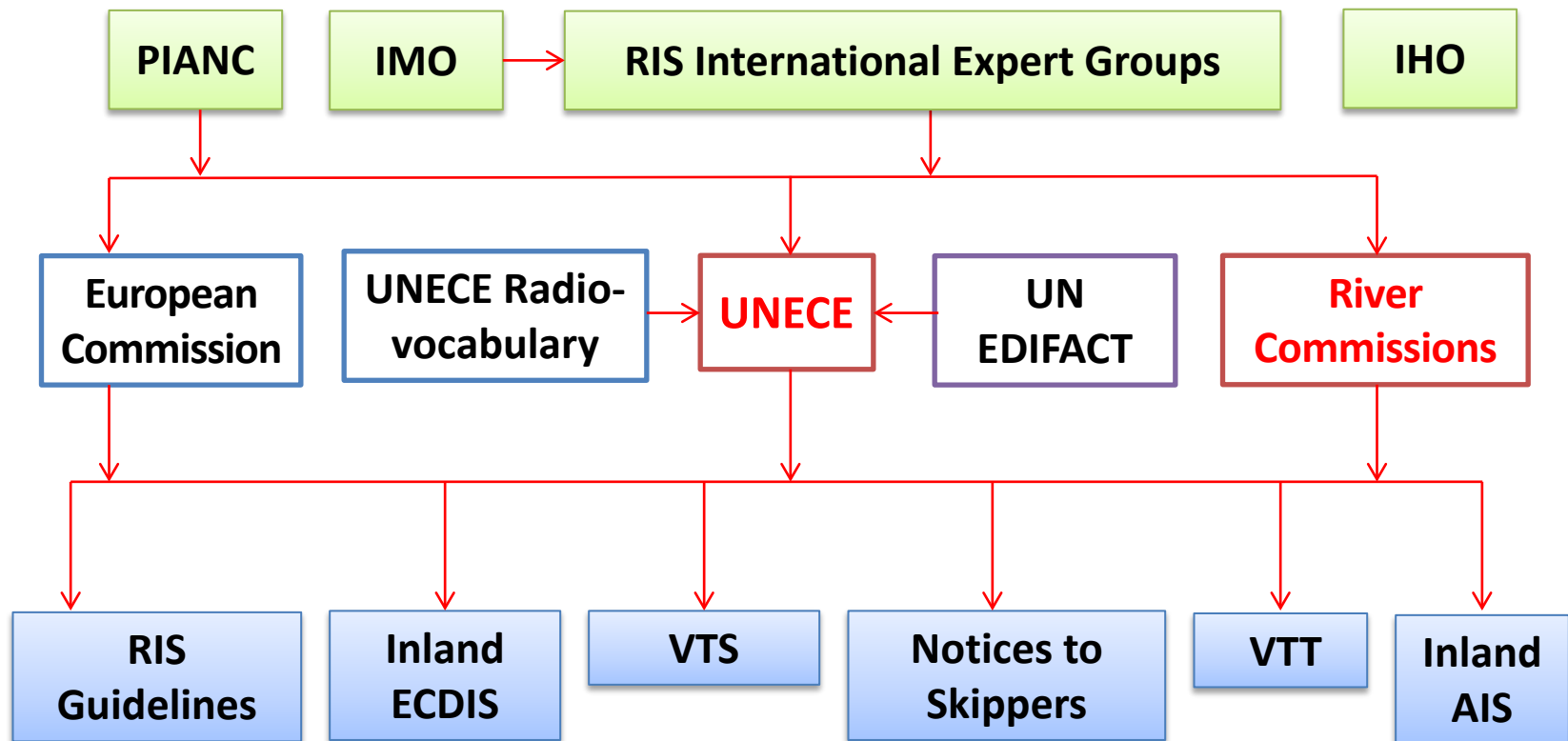

- Resolutions Nos **48** (Inland ECDIS), **57** (RIS Guidelines), **58** (VTS), **63** (VTT), **79** (ERI): pending
: waiting for the European Commission and the RIS Expert Groups
- **RIS: permanent agenda item of SC.3 and SC.3/WP.3**
- **Workshop** “RIS and other ICT in the pan-European format”

- **High-Level Conference on IWT** (22 February 2017)

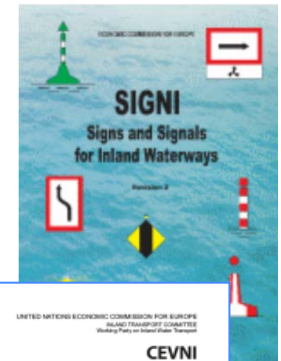
- Updating **SIGNI** and **CEVNI**

Signs and Signals on Inland Waterways

Chapter 12, DRAFT on monitoring of signs and marking by AIS Aids to Navigation (AtoN)

- Implementation of **UNECE Resolutions** (out of 27 member States)

48 (Inland ECDIS)	9	3
57 (RIS Guidelines)	10	2
58 (VTS)	6	5
63 (VTT)	7	3
79 (ERI)	8	3
80 (NtS)	14	3



Challenges, Opportunities & Lessons Learned

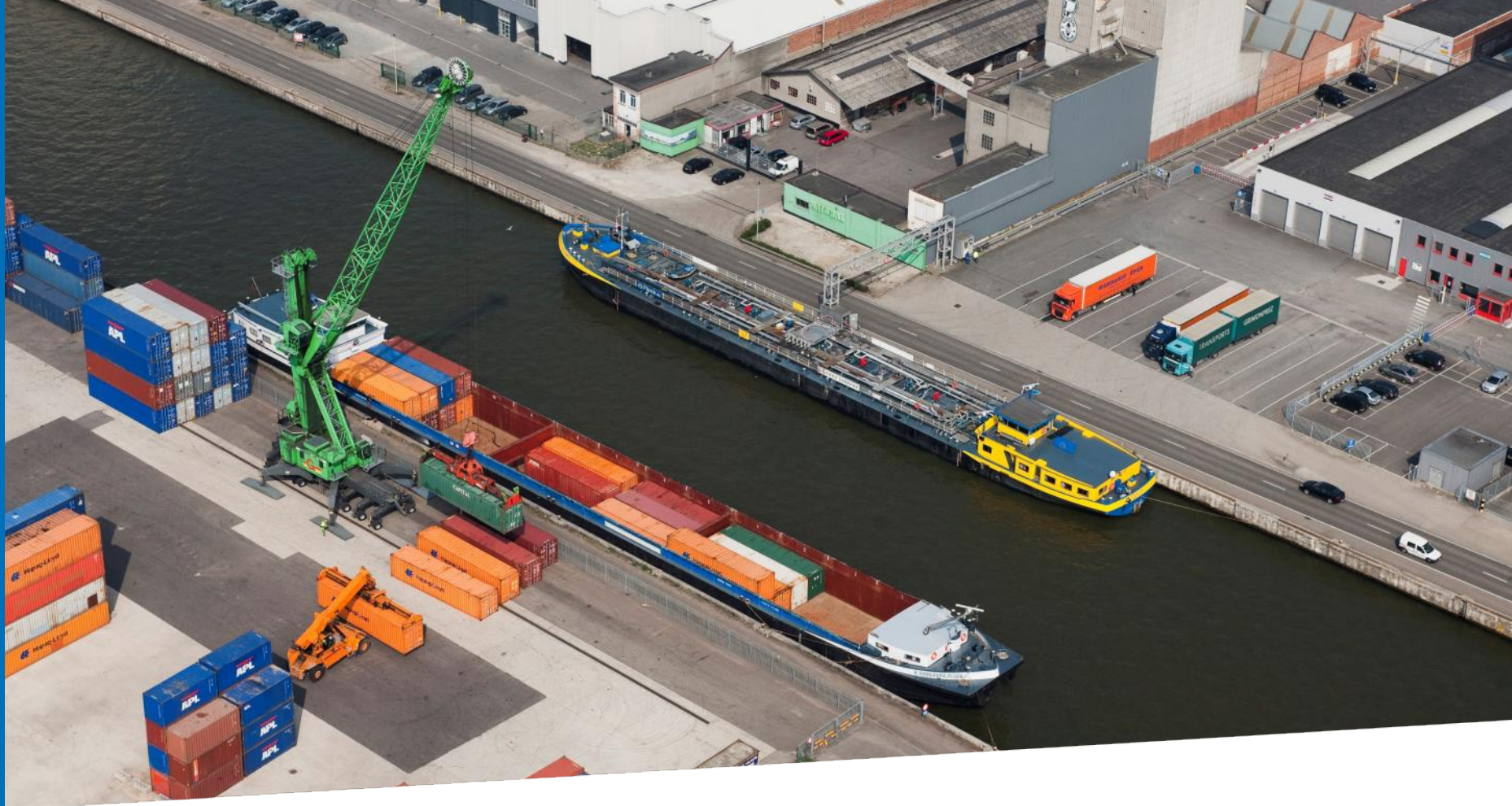
- Introducing **RIS provisions in UNECE documents**
- **Harmonization of standards** and coordination with International Expert Groups, EU and River Commissions
- **RIS at international events: promotion and best practices**
e.g. International Conference on IWT (18-19 April 2018, Wroclaw, Poland)
- Coordination of **activities of UNECE member States** and **providing tools for RIS implementation** at the national level
- Providing **feedback to International Expert Groups**
- Supporting **innovations and digitalization**
- Addressing **RIS at a broader scope** with Inland ENCs and Navigation Rules

High-Level Conference on IWT

(Geneva, 22 February 2017)

- RIS in terms of the efficiency, safety and security of navigation
- Need for innovations, modern technologies, data exchange and digitalization
- IALA: milestones will include:
 - ✓ RIS: further development
 - ✓ e-Navigation
 - ✓ Vessel Traffic Services (VTS) and traffic management in IWT
 - ✓ other opportunities by new technologies
