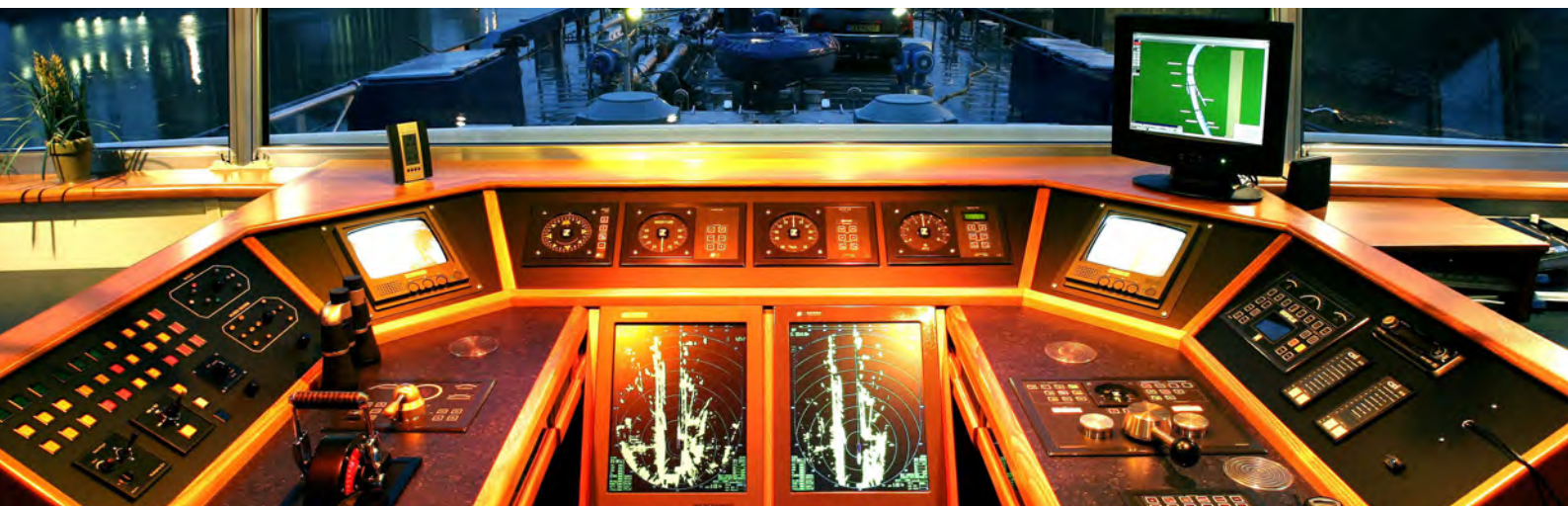

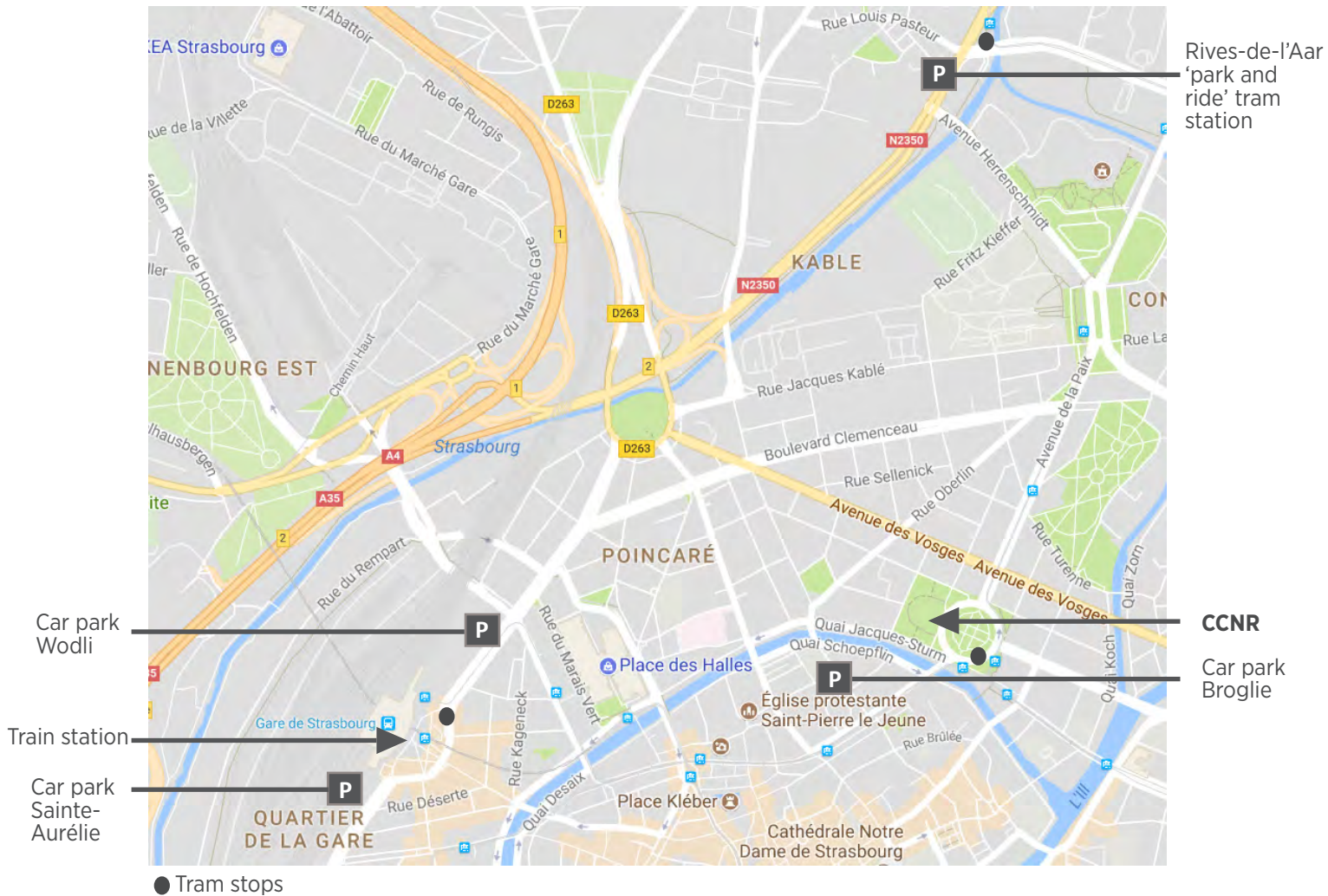

Tram B, stop "Rives de l'Aar" at stop "République", direction "Lingolsheim" (12 min, every 9 min)
